



You are about to use the visitor pre-registration service for the event 'JEC Forum Southeast Asia 2024', operated by our partner Grip.

These General Terms and Conditions ("GT&C") apply to any order made online by users (hereafter "Clients") via the website <u>https://business-</u> <u>meetings-registration.jeccomposites.com/jec-</u> <u>forum-southeast-asia-2024/register</u> (hereafter "the Website") involving products and services proposed by JEC (hereafter "the Company"), and are given for the purpose of specifying the conditions governing all pre-registration requests to attend the event JEC Forum Southeast Asia (hereafter "the Event"), as a visitor.

These general terms and conditions may be modified or adapted by the Company at any time. Users will be notified of all modifications to these general terms and conditions, and any of the documents to which they refer, upon their first visit to the Website after the modifications have been made.

The general terms and conditions which apply are the ones in effect on the day of purchase or on the day the booking request was received by the Company.

These conditions are applicable to all Client holders of a visitor's admission ticket.

PRE-REGISTRATION REQUEST PROCESS

Before submitting a request for pre-registration, Clients explicitly declare that they are aware of these general terms and conditions and accept them unconditionally and irrevocably, by clicking "Confirm and Check Out" I hereby certify that I have read and accepted the GT&C.

JEC reserves the right to amend unilaterally these Terms of Use at any time (without notice). Any such amendments will take effect as of the time of publication on this Website. JEC further reserves the right at its absolute discretion to take down or change the whole website or any part thereof.

ARTICLES

It should be clearly understood that the articles sold on the Website, Entrance Passes (hereafter "the Entrance passes"), are reserved for professional clients.

PRICES

Prices for products and services available at the Event shall be as indicated at the time of purchase on the Event's Website. The Company reserves the right to change or modify the prices at any time without notifying.

Prices of articles (entrance passes) are expressed in US dollars. Prices in US dollars are detailed in the proof of purchase.

PAYMENT

Articles (Entrance passes) are payable at the time of ordering. All orders, whatever their source, must be paid for in US dollars. Payment of entrance passes must be made online via the website https://business-meetings-

registration.jeccomposites.com/jec-forum-

southeast-asia-2024/register, by means of a valid bank card.

Accepted payment cards are Visa / Eurocard-Mastercard / American Express.

The full value of your order will be charged to your valid bank card as soon as it has been confirmed.

Charging of the payment to your valid bank card is independent of the actual printing of badges or delivery of other articles purchased.

Unless evidence is provided to the contrary, the data recorded by the Company constitutes proof of all transactions between the Company and its Clients.

The data recorded by our payment system constitutes proof of transaction.

SECURITY OF PERSONAL DATA

The Company, as data controller, processes the Client's personal data to manage its order and its business relationship with the Company in accordance with these General Terms and Conditions of Visitor Registration and Participation. Said information and personal data will also be processed to ensure the safety of goods and people within the event premises to comply with the Company's legal and regulatory obligations, as well as for targeted solicitation purposes according to the preferences and interests of visitors.





The Client agrees for JEC Forum Southeast Asia that the personal data she/he provided during registration may be passed on, for marketing purposes, to sponsors at the event whose content she/he views on the website or onsite or saved in her/his favourites list, with whom she/he contacts or with whom she/he arranges appointments. The Client is aware that the sponsors may be located outside the scope of the EU General Data Protection Regulation (GDPR).

Depending on the choices made by the Client on its pre-registration request, the Client may also receive, by any communications channels, business proposals and news on the Company's activities and services.

The Client's personal data may be processed, based on the consent (which he may withdraw at any time) to communicate to him business proposals and news about other JEC events and/or their partners, by any communications channels.

Only the Company's in-house teams and the service providers that it has authorized in connection with the organization and management of the event will have access to the Client's personal data. If applicable, these data can be communicated to third parties, according to the Client's choice (the Company's partners).

The personal data that must necessarily be provided are indicated as such on the form and are necessary for the conclusion and performance of the contract between the Client and the Company. The Company will not be able to process the Client's requests without said data.

In accordance with the applicable regulations, the Client has a right of access, a right of rectification, a right to delete data, a right to object to the processing of its data, and to limit its processing, and a right regarding the portability of its data. The Client also has the right to define directives concerning the fate of his data after his death in accordance with French law. The Client may exercise these rights at any time by writing to the company JEC – 251, Boulevard Pereire – 75017 Paris, France, or by email at jec@jeccomposites.com. Finally, the Client has the right to lodge a complaint with France's Commission nationale de l'informatique et des libertés (the "CNIL").

The Client's personal data will be retained for the duration of its commercial relationship with the Company and then for a period of three sessions from the date on which the Client most recently expressed an interest. In any case, the retention period never exceeds 3 years after the last contact between the Company and the Client.

Beyond this period, the data are kept as evidentiary archives for the duration of the legal prescription.

CONFIRMATION OF PRE-REGISTRATION REQUEST

The Company will systematically confirm all preregistration requests by means of an email sent to the Client (at the email address written on the registration form).

If you do not receive your confirmation email, please write to the Company at perraudin@jeccomposites.com.

DELIVERY OF ENTRANCE PASSES

Once the order has been placed and paid online, the Company will send the Client an email (at the email address written on the registration form) inviting them to print their Entrance pass(es), attached to this email in PDF form, on a standard printer (inkjet or laser) with internet access.

One PDF file will be created for each Entrance pass. Entrance passes are STRICTLY personal (pass holders may be requested to show proof of ID at the entrance) and non-transferable. You may not procure registrations as an agent for any third party, sell or otherwise transfer your registration / Entrance pass to others, or exploit your registration commercially or non-commercially in any way.





CANCELLATION - MODIFICATION - REFUNDS - USE

All orders placed online are firm and definitive, constituting an irrevocable commitment to pay the corresponding price in full.

As a result, no refunds will be offered for any reason whatsoever, including partial or total cancellation of the order.

By the same token, the Company will not accept any modifications to the Entrance passes as originally ordered.

Clients are encouraged to check all information carefully before confirming their orders.

The impossibility to attend the Event or any mistakes made when purchasing the tickets (for instance, writing your email address incorrectly during the purchase process) are not grounds for reimbursement of the Entrance Pass.

WAIVER OF THE RIGHT OF WITHDRAWAL

In accordance with Article L221-28 of the French Consumer Code, Entrance passes to the Event and similar events are not covered by the right of withdrawal, unless due to the sanitary crisis, the client addresses a transfer request to perraudin@jeccomposites.com, two weeks prior to the Event.

PLEASE REMEMBER THAT PASSES CANNOT BE TRANSFERRED

Touting of Entrance passes via the Internet is a criminal offense punishable by arrest and prosecution, with a maximum fine of €15,000 (Art. 313-6-2 of the French Criminal Code).

If the Event or conferences to which the Client has registered is cancelled, or the dates or times are changed, the Client accepts that the Company may use the contact details provided when placing the order online to inform them of the measures to be taken.

If the event is cancelled by the Company on account of an incident of force majeure, as defined in French law, the Company will inform all Clients without delay. In such cases, no damages or interest will be payable.

IMAGE RIGHTS

The Client explicitly authorises, without any expectation of remuneration, the Company, and JEC:

- to record, if they so wish, photos and/or videos featuring the Client in their capacity as a visitor to the Event or other events relating thereto.
- to make free use of these images in any format, particularly for promotional purposes (including without limitation, offline, online web pages, and social networks, as well as in press releases, and electronic media with promotional and advertising purposes) in France and internationally, for a period of five years (free of charge) starting from the date on which the Client's pre-registration request is confirmed. By accepting these General Terms and Conditions, you hold the Company harmless against any liabilities for damages connected with the use of your image.

Clients who do not wish to feature in photographs or films made during the Event must notify the Company in writing before the start of the Event.

Any Clients wishing to take their own photos/videos of the Event must also inform the Company by writing in advance.

Clients will take sole responsibility for obtaining the necessary authorisations for any images recorded during the Event, and for respecting the image rights of all exhibitors, visitors, and participants present at the Event.

In accordance with article 10 of Law 9573 of 21/01/1995 visitors may be filmed by a video surveillance system.

INTELLECTUAL PROPERTY

All content included in and/or made available on the Website such as e.g., elements, texts, logos, images, sounds, software, digital downloads, data compilations, graphics, and button icons and reproduced on the Website are protected by intellectual property rights all over the world.

As such it is strictly forbidden to modify, represent, reproduce, transfer, or use all or part of the Website and its content in any form or by any means.





It is forbidden to use the Website for commercial purposes without the express and written authorization of the Company.

APPLICABLE LAW- DISPUTES

The pre-registration service provided by the Company on the Website is governed by and construed in accordance with French law without regard to its conflict of law provisions.

If any of the provisions are canceled or considered to be unenforceable by a court decision, then the remaining provisions of these General Terms and Conditions shall remain in full force.

In the event of a dispute arising in connection with, or arising out of the existence, validity, interpretation, performance, and/or termination of these General Terms and Conditions, the Parties undertake to seek an amicable resolution with the possibility of using a mediator. If the parties fail to reach an amicable solution, the courts of Paris (France) shall have exclusive jurisdiction to hear such dispute which the parties expressly accept.

COMPLIANCE

The Client shall, at all times, abide by all applicable legal requirements and economic sanctions relevant to its duties, obligations, and performance under this agreement including (i) Economic and trade sanctions and export controls (including, without limitation, those enforced by the US, EU, UK, and UN), and (ii) applicable anti-corruption and related laws s), obligations, and internal business practices that shall be transmitted to the Company and shall obtain any permits or licenses necessary for its operations. The Client shall not undertake any action in violation of any applicable legal requirement that could result in liability being imposed on the Company. The Client engages to comply with the internal policies disclosed by the Company and any requirement edited by those.

SANITARY and HYGENIC SECURITY MEASURES

In order to ensure a pleasant visitor experience for all, the Visitor undertakes to comply with all compulsory sanitary measures in force during the Event. The Visitor knows, accepts, and is responsible for the accomplishment of those measures at any time during his visit to the Event.

CANCELLATION - FORCE MAJEURE

If the Company observes that the Event cannot take place within the conditions foreseen owing to exceptional circumstances. whether these constitute a case of force majeure as per article 1218 of the French Civil Code and whether these are entirely unpredictable (hereafter "exceptional circumstances") the Company may notify the cancellation of the Event. Shall be qualified as exceptional circumstances the following events: (fire, flood, storm, destruction or unavailability of the venue(s) or location(s) where the Event is to be held, accident, incidental case, strike action at the local or national level, riots, risk of safety, terrorist threat, administrative ban or closure, health situation, potential consequences of the Covid-19 epidemic, cancellation of the participation of a significant proportion of the participants, restriction of movements of participants or visitors, etc.,

The Company may also cancel the Event in case of a force majeure event as recognized by French law. Parties agree that Force majeure events include as well:

- Events that render the Event impossible, regardless of the cause, and listed nonexhaustively below:
 - strikes
 - fire, explosion, flood, violent storm, lightning damage, snowstorm,
 - any legislative, administrative decision to close or requisition the venue of the Event, or forbidding gatherings, exhibitions, conferences, and more generally events
- any event making it impossible for the Company to perform the Event, even if the Event was predictable upon the Client's registration.
- All external events triggered a natural disaster decree from the French Government. In case of force majeure, the Company is entitled to reschedule the Event within the same calendar year or the immediate next calendar year, subject to the venue availability.





In case of the cancellation of the Event because of a force majeure event, consequences will be dealt with as follows:

Payments processed by Clients upon cancellation date will be kept by the Company, upon completion of the process described further.

The Company will propose to the Client to transfer all payments received from the Client to the immediate next edition of the Event, provided that the Client agrees. In the event the Entrance Pass holder is not available to attend the next edition of the Event, the Entrance Pass may exceptionally be transferred to another person from the same organization. In the event no other person is available to attend the next edition of the Event, the Company shall refund the Client's Entrance pass upon the Client's written request sent by email at the following address:

The Company may change the date and/or place of the Event for organizational, technical, or other justifiable reasons. The Company undertakes to communicate any such changes to the Visitors as soon as possible to reduce any inconveniences. Said communication will be made to the Visitor at the email address written on the registration form.
